Note- All membership applications require a criminal background investigation. All flying positions require approval/vetting from TSA/DHS for flying in the national capital region SFRA/FRZ.

All persons applying for membership should provide copies of the following documents with this application; drivers' license, Birth Certificate or US passport, any first responder-cpr, EMT, fire, law enforcement, SAR or pilot certifications, pilot medical certificate and any certificates of training relevant to our mission.

Applications must be submitted with original signature in person to a VARS Officer. Membership is appointed by the Chief upon recommendation of the Board of Directors after review.

Since the VASARS is a non-profit 501C3 organization providing free airborne search & rescue services to rescue squads, fire departments, law enforcement agencies, federal agencies and SAR groups, it is expected that you will agree to assist in fundraising and public relations at all times while volunteering with VASARS. Our first mission is life safety and SAR, second is raising the funds necessary to support such activities with 100% going to training and airborne SAR.

As a volunteer, it is expected that you will become trained, proficient and remain current in order to perform your volunteer duties safely and with respect to our missions. All members will have to maintain current CPR/AED certifications and first responder certifications and above for Flight Officers.
